**MINUTES** of the St Eval Parish Council meeting held at the St Eval Parish Hall on Wednesday 3<sup>rd</sup> February 2016.

394/16 **Declarations of Interest:** None were declared.

395/16 **Minutes:** The Minutes of the Meeting on 6<sup>th</sup> January 2016 were taken as read, approved and signed by the Chairlady. Prop: JF Sec: PS All Supported.

The following item 396/15 a] was not on the Agenda but was due to be discussed Under “Parish Matters”.

### 396/16 **Matters arising from previous Meeting**

a] Porthcothan Beach. The Chairlady informed the meeting that she had a meeting at Porthcothan beach with representatives of CC, regarding the current situation of the course of the stream and the worry about further erosion.

CC pointed out that any proposed work that is envisaged been carried out on the Beach, CC must be informed about first. It is then compulsory that the following Agencies also be informed: 1] The Inshore Fisheries & Conservation Authority. 2] Natural England. 3] The Environment Agency. 4] The AONB.

Then it would depend on the comments of all parties, whether the intended works would proceed. Jolyon Sharpe, CC will now complete his report with his directions as to the current way forward.

b] Car Park Toilets. The Clerk informed the meeting that CC has agreed to pay a percentage of the car park revenue by 1<sup>st</sup> April and also to install turnstiles for an entrance payment, which the PC would receive. Providing all these points are in writing the meeting agreed that the PC would keep the Porthcothan Car Park toilets open for a lease period of two years, from 1<sup>st</sup> April 2016.

c] St Eval Recycling site Mobile homes. The Clerk informed that CC Planning Enforcement have visited the site are further enquiries are taking place.

### 397/16 **Denzill Downs Community Fund**

A meeting had taken place on 19<sup>th</sup> January where representatives of the Parishes Involved were present. It is to be confirmed when monies would be ready for distribution, but the first meeting to evaluate any community funding applications will probably be in April.
