### 495/17 **Election of Chairman for the forthcoming year**

Mick Baker proposed Kim Hayward to be re elected as Chairlady and was seconded by George Alecock. KH accepted and duly signed the Acceptance of Office form.

### 496/17 **Election of Vice Chairman for the forthcoming year**

George Alecock proposed Mick Baker to continue as Vice Chairman and was seconded by Joyce Froome. MB duly accepted the position.

### 497/17 **Declarations of Interest:** None were declared

498/17 **Minutes:** The Minutes of the Meeting on 5<sup>th</sup> April 2017 were read, approved and signed by the Chairlady. Prop: MB Sec: JF All Supported.

### 499/17 **Planning Applications**

PA17/03369 Mr Searle Mawgwen, Treburrick. Demolition of existing lawful development and construction of replacement dwelling. Installation of new treatment plant and stormwater soakaways.

After discussion the Councillors unanimously voted to Object to this Application on the grounds that the proposed dwelling would be too large for the site and is not within the footprint of the existing building, which is contrary to the Parishes Neighbourhood Development plan.

### 500/17 **St Eval Parish Council Annual Return**

The Clerk presented the completed return. The Internal audit was carried out by GA. The Chairlady duly signed the document, which will be sent to Grant Thornton for the external audit.

### 501/17 **Porthcothan Toilets**

The Clerk explained that he had not signed the annual cleaning agreement which Cormac has agreed to. Also still awaiting the Lease agreement which is being updated to the current year.

**502/17 Porthcothan Bay Speeding**

A letter has been received from a resident regarding speeding on the coast road at Porthcothan bay.

After discussion it was resolved to see if Temporary speed limit LED signs could be installed to deter this problem.

**503/17 Parish Footpaths**

a] From the information received, there is concern about the current closure between Footpath 10 and the unclassified road at Downhill, by the owners of Carnewas farm.

No formal correspondence has been received by the PC from CC, therefore it was agreed to contact CC for their opinion on the matter.

b] Chris Moncaster has agreed to act as Footpath Survey Officer.

**504/17 Porthcothan Beach Flytipping**

The PC has received complaints from both residents and visitors about the amount of garden waste that is and has been dumped on the cliff edge by some of the properties on the Porthcothan headland.

The meeting agreed to send appropriate letters to the houses concerned.
